REQUEST FOR WRITTEN QUOTE

Quotes must be on company letterhead with a date and signature of an authorized representative of the vendor. All vendors providing written quotes must have the required expertise and capability to perform the work or supply the commodities or equipment. In determining if a vendor has the capability to perform the work or supply the commodities or equipment, consideration shall be given to the vendor's geographic proximity to the county for future ease of delivery, mobilization, or customer support after a purchase. The lowest cost, responsible and responsive vendor who is capable of performing the services or supplying the commodities or equipment shall be awarded the contract.

PURPOSE:

The Board of County Commissioners is seeking written quotes from licensed and insured vendors with the required expertise and capability to perform the work or supply the commodities or equipment for: **(2) Open Pole Barn Kits for the Public Works Department.**

TIME AND DELIVERABLES:

The selected vendor shall be expected to complete all necessary and required services pursuant to this quote within **30** days from the issuance of a Notice to Proceed, as approved and signed off by the County.

WARRANTY:

The vendor awarded will be required to provide minimum one year warranty on labor and materials.
