REQUEST FOR WRITTEN QUOTE No. 2018-08

Quotes must be on company letterhead with a date and signature of an authorized representative of the vendor. All vendors providing written quotes must have the required expertise and capability to perform the work or supply the commodities or equipment. In determining if a vendor has the capability to perform the work or supply the commodities or equipment, consideration shall be given to the vendor's geographic proximity to the county for future ease of delivery, mobilization, or customer support after a purchase. The lowest cost, responsible and responsive vendor who is capable of performing the services or supplying the commodities or equipment shall be awarded the contract.

PURPOSE:

The Board of County Commissioners is seeking written quotes from licensed and insured vendors with the required expertise and capability to perform the work or supply the commodities or equipment for: **Wakulla Gardens Holding Pond Fencing.**

SCOPE OF SERVICES TO BE PROVIDED:

Provide labor and materials for a Chain Link Fence to be installed around a holding pond located at the corner of Cochise St. and Oneida St., in response to the Wakulla Gardens Sewage and Paving efforts. Summary is as follows:

- Labor and all materials to install a 4' tall black vinyl 9gauge chain length fence around a holding pond
- Public Works has a rough estimate of 350 feet in length needed; however, pricing **must** be provided at a **per-foot rate**, as the exact length of the fence is not yet known.
- Fence will include a 10' X 4' gate

PRE-QUOTE SITE VISIT:

The selected vendor shall be fully informed as to all existing conditions and limitations that affect the work to be performed hereunder. Failure to become familiar with site conditions will in no way relieve the successful vendor from the necessity of furnishing any materials or performing any work that may be required nor shall it be grounds for a change order for work that would have been apparent had a site visit been made.

TIME AND DELIVERABLES:

The selected vendor shall be expected to complete all necessary and required services pursuant to this quote within **14** days from the issuance of the Notice to Proceed, as approved and signed off by the County.

WARRANTY:

The vendor awarded will be required to provide minimum one year warranty on labor.

Quote Responses are Due By: March 13, 2018 @ 3:00 p.m. and will be received by the Procurement Office located at 3093 Crawfordville Hwy, Crawfordville, Florida 32327.
