Quotes must be on company letterhead, a county approved quote form, or in a similar format with a date and signature of an authorized representative of the vendor. All vendors providing written quotes must have the required expertise and capability to perform the work or supply the commodities or equipment. Consideration will be given to the vendor who has the capability to perform the work or supply the commodities or equipment, consideration shall also be given to the vendor's geographic proximity to the County for future ease of delivery, mobilization, or customer support after a purchase. The lowest cost, responsible and responsive vendor who is capable of performing the services or supplying the commodities or equipment shall be issued a purchase order.

**PURPOSE:**

The Board of County Commissioners is seeking written quotes from licensed and insured vendors with the required expertise and capability to perform the work or supply the commodities or equipment for: **Community Center Lighting – East Building**

**SCOPE OF SERVICES TO BE PROVIDED:**

Vendor will be responsible for providing all equipment, materials and other items required to remove and dispose of seven (7) existing wall pack light fixtures. Vendor will replace with seven (7) new LED wall pack lights. Price shall include all labor, supplies, materials and equipment necessary to install the new fixtures. The new lights will be Atlas WLM43LED wall lights or approved equal.

Final Completion shall be expected within thirty (30) days of the issuance of a purchase order, unless otherwise approved in writing by both Parties. **The selected vendor must also have general liability insurance necessary to complete the project.**
