A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF WAKULLA COUNTY, FLORIDA FOR THE CONTRACT AND FUNDS IN THE AMOUNT OF \$103,600.00 (no matching funds required), FROM STATE OF FLORIDA, DEPARTMENT OF COMMUNITY AFFAIRS, AND THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR THE WEATHERIZATION-LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM (WAP-LIHEAP).

WHEREAS, The Board of County Commissioners of Wakulla County, Florida has received a Contract from the Department of Community Affairs for the Weatherization-Low-Income Home Energy Assistance Program (WAP-LIHEAP)
