**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF WAKULLA COUNTY, FLORIDA FOR THE CONTRACT AND FUNDS MODIFICATION IN THE AMOUNT OF \$ 40,000.00 (no matching funds required), FROM STATE OF FLORIDA, DEPARTMENT OF COMMUNITY AFFAIRS, AND U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES, FOR THE WEATHERIZATION-LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM (WAP-LIHEAP).**
