A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF WAKULLA COUNTY, FLORIDA FOR THE 2009-2010 CONTRACT AND FUNDS IN THE AMOUNT OF \$157,474.00 (no matching funds required), FROM THE DEPARTMENT OF COMMUNITY AFFAIRS DIVISION OF HOUSING AND COMMUNITY DEVELOPMENT, FOR THE LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM (LIHEAP).

WHEREAS, The Board of County Commissioners of Wakulla County, Florida has received a Contract from the Department of Community Affairs for the Low-Income Home Energy Assistance Program (LIHEAP);

WHEREAS, those funds hereinafter described were received for a particular purpose; and

WHEREAS, Chapter 129.06, Florida Statutes, provides that the Clerk at any time within a fiscal year may amend a budget for that year when there is a receipts of funds from a source not anticipated in the budget and received for a particular purpose, and expend it for a particular purpose; and
