The County of Wakulla (herein referred to as the "County") Sealed Bids marked "Sealed Bid" Community Development Block Grant Project for the fiscal year 2007, to be financed by the State of Florida Department of Community Affairs, will be received by the County for the construction of the Project described as follows:

The Contractor selected is to perform and/or provide the necessary resources for the installation and testing of approximately 495 feet of new potable water mains, 885 feet of gravity sewer, 6 manholes, 7690 feet of sanitary sewer force main, 1 sanitary sewer pump station and associated appurtenances, 2 Type J inlets, 165 LF of 15" RCP, driveway connection to pump station, 1035 square yards of roadway improvements including type D curbing. The selected Contractor will also be required to implement the special conditions of a CDBG grant, for the project.

Bids shall be addressed to Wakulla County Board of County Commissioners at 3093 Crawfordville Highway (Commissioner's Complex) Crawfordville, FL 32327 and delivered to no later than 2:00 PM, on December 19, 2007. Bids shall be designated as "Sealed Bid" Community Development Block Grant Project for the Fiscal Year 2007.

All bids must be submitted in triplicate. Any bids received after the specified time and date will not be considered. The sealed bids will be publicly opened and read aloud in the Wakulla County Board of County Commissioners Office Complex Building on December 19, 2007 immediately following the submittal deadline.
