#### **PURPOSE**

Wakulla County is seeking proposals for replacing the roofs on the Building Department and the Housing Department offices.

#### **BID DEADLINE**

Bids must be dated no later than Thursday, June 5, 2008.

#### **SCOPE OF WORK**

The Scope of Work will require laying a ½ inch foam moisture barrier to the existing roof, new boots and ventilation, then installing new copper colored standing seam metal roofing system with soffit, fascia and eve drip metal. Roof specifications and design must continue Board of County Commissioners appearance and quality.

The installed roof must meet all Florida building and construction Codes
