RESOLUTION NO. 2022- 04

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF WAKULLA COUNTY, FLORIDA, ADOPTING AN AMENDED AND RESTATED FEE SCHEDULE FOR USE OF COUNTY PARKS, FACILITIES, AND RECREATIONAL FACILITIES; REPEALING PRIOR AND CONFLICTING RESOLUTIONS AND FEE SCHEDULES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Florida Statutes 125.01(f) authorizes and empowers the Board of County Commissioners of Wakulla County ("Board") to provide parks, preserves, playgrounds, recreation areas and other recreational facilities and programs; and

WHEREAS, Chapter 23 of the Wakulla County Code anticipates that certain use, rental, and reservation fees will be established by the Board for use of County parks, facilities, and recreational facilities; and

WHEREAS, the Board adopted Resolution No. 08-25 adopting fees for use of County parks and recreational facilities; and

WHEREAS, the Board adopted Resolution No. 12-34 establishing revised rates, fees, and charges for use of the County parks and recreational facilities; and

WHEREAS, the Board adopted Resolution No. 14-22 establishing new fees for the use, rental, or reservation of County parks and recreational facilities; and

WHEREAS, the Board adopted Resolution No. 15-35 amending the park and recreational facilities use, rental, and reservation fees in order to more effectively cover the costs associated with the provision of those facilities and the administration of parks and recreation programs; and

WHEREAS, the Board adopted Resolution No. 18-19 amending the parks and recreational facilities use fees in accordance with Ordinance No. 2016-09 relating to Special Events, Ordinance No. 17-04 allowing for the sale and consumption of alcohol at special events on certain County property, and other minor revisions; and

WHEREAS, the Board adopted Resolution No. 19-38 amending the fee schedule to add an hourly field rental, a new fee for temporary fences, and additional maintenance services on game days, at Medart Recreation Park, and

WHEREAS, the Board adopted Resolution No. 21-52 amending the fee schedule to increase youth user fees, add a new fee for late registration and remove youth tackle football and cheerleading, at Medart Recreation Park, and

WHEREAS, additional revisions are recommended for Newport Campground, Hickory Park, Panacea Community Center, and the Wakulla Extension Office to provide increased flexibility in rental times, increased fees, elimination of certain rentals, and the addition of certain facility rental space.

WHEREAS, the Board of County Commissioners has reviewed the recommended fee schedule and has determined that the revised fees and charges set forth in the attachment to this resolution are fair and equitable and necessary to fund the proper operation of the County's parks, facilities, and recreational facilities and programs; and

WHEREAS, the Board of County Commissioners finds that it is in the best interests of the citizens of Wakulla County to adopt an amended and restated schedule of fees and charges for the use, rental, and reservation of County parks, facilities, and recreational facilities; and

WHEREAS, the Board now wishes to repeal prior and conflicting resolutions and fee schedules.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WAKULLA COUNTY, FLORIDA, AS FOLLOWS:

SECTION 1. FINDINGS. The above findings are true and correct and are hereby incorporated herein by reference.

SECTION 2. PARK USE, RENTAL AND RESERVATION FEES. The fees for use, rental, and reservation of County parks, facilities, and recreational facilities shall hereby be

imposed at the rates and in the amounts specified in the fee schedules attached hereto and incorporated herein as Exhibits A and B to this Resolution.

SECTION 3. REPEAL. Resolutions 08-25, 12-34, 14-22, 15-35, 18-19, 19-38, and 21-52 are hereby repealed in their entireties and replaced with this amended and restated fee resolution.

SECTION 4. EFFECTIVE DATE. This resolution shall be effective upon adoption by the Board of County Commissioners of Wakulla County, Florida, and the fees established herein shall become effective upon the date of adoption.
